

MAIL-IN ABSENTEE BALLOT VOTING

*Completed application **MUST** be received by the County Clerk
by mail or in person by voter
to County Clerk seven(7) days before the election.*

QUALIFICATIONS FOR VOTING BY MAIL-IN ABSENTEE BALLOT

1. Voter who due to age, disability or illness will be unable to go to the polls
2. Student who temporarily resides outside the county in which he is registered.
3. Voter who temporarily resides outside the state but who is still eligible to vote in Kentucky.
4. Person who is incarcerated in jail and has been charged with a crime but has yet to be convicted of the crime.
5. Person whose employment location requires him to be absent from the county all hours and all days absentee voting by machine is conducted.
6. Voter who temporarily resides overseas.
7. Voter who is a member of the Armed Forces or the dependent of a member of the Armed Forces.
8. Military personnel confined to a military base on election day.
9. Voter who moved to another state after its voter registration books closed. Presidential Election only.

**Voter must complete numbers 2-9 in full on the application
Instructions for completing number 10-17:**

10. **You checked Box 10**, the ballot may be mailed to your home.
11. **If you checked Box 11**, the ballot must be mailed to an address out of the county.
12. **If you checked Box 12**, the ballot must be mailed to an address out of state.
13. **If you checked Box 13**, the ballot must be mailed to the jail at which you are incarcerated.
14. **If you checked Box 14**, the ballot must be mailed to your home.
15. **If you checked Box 15**, the ballot may be mailed to a military base within you county of residence.
16. **If you checked Box 16**, the ballot must be mailed to an address out of the county.
17. **GIVE FULL MAILING ADDRESS, INCLUDING ANY APARTMENT OR POST OFFICE BOX AND ZIP CODE.**

**BE SURE TO READ, DATE AND SIGN THE OATH ON THE FRONT OF THE APPLICATION
OR YOUR APPLICATION WILL NOT BE VALID.**

Penalties:

RS 117.995(2) Any county clerk or member of the county board of elections who knowingly and willfully violates any of the provisions of this chapter, including furnishing applications for absentee ballots to persons other than those specified by the provisions of this chapter and failure to type the name of the voter on the application form as required by the provisions of this chapter, shall be guilty of a Class D felony.

(5) Any person who signs a name other than his own on an application for an absentee ballot or on the verification form for the ballot or on an emergency absentee ballot affidavit, or any person who votes an absentee ballot other than the one (1) issued in his name, or any person who applies for the ballot for the use of anyone other than himself or the person designated by the provisions of this chapter, or any person who makes a false statement on an application for an absentee ballot or on an emergency absentee ballot affidavit shall be guilty of a Class D Felony.

Ballots may not be mailed to addresses in Jefferson County except for those voters who qualify under numbers 10 and 14 above.

Voters who will be out of the county on election day, including vacationers may choose to vote by mail or to vote at the Board of Elections Office during the hours listed below.

A woman in her last trimester of pregnancy at the time she wishes to voter may also vote at the Elections Office during the dates and times listed below. (Effective 3-17-00)
