## Qualified Voters Can Visit the Jefferson County Clerk Election Center To Cast Ballots

LOUISVILLE, Ky. (10/25/2022): Starting Wednesday, Oct. 26, 2022 and over the following six business days, eligible Jefferson County voters who meet one of eight required criteria can cast an in-person excused absentee ballot at the Jefferson County Clerk Election Center on E. Liberty Street.

"Just like in the Primary Election, we're glad to serve our community and make voting more convenient through more choices," said Jefferson County Clerk Bobbie Holsclaw. "If you have one of the reasons set forth in the bipartisan legislation passed this year, we're happy to have you cast your ballot during the in-person excused absentee balloting period. If not, we look forward to you casting your vote at one of the <u>seven in-person no excuse absentee balloting</u> <u>locations</u> Nov. 3-5, or at your <u>precinct polling location</u> on Election Day Nov. 8."

## Who qualifies for an in-person excused absentee ballot:

- 1. Military or Overseas voters covered in 117A.010 & a resident of KY who is a uniformed service voter confined to a military base on Election Day or all days of in-person no excuse absentee (early) voting.
- 2. Student who temporarily resides outside the county of his/her residence.

- 3. Voter who temporarily resides outside the state but is still eligible to vote in this state and will be absent from the county of his or her residence on election day and during the days of no-excuse in-person absentee voting.
- 4. Voter or voter's spouse who has surgery scheduled that will require hospitalization the day of an election and during the days no excuse in-person voting.
- 5. Voter who is in her last trimester of pregnancy and completes the form prescribed by Kentucky State Board of Elections.
- 6. Voter who cannot appear during Election Day or no excuse in-person absentee voting due to age, disability, or illness and has not been declared mentality disabled by a court.
- 7. Any person who is employed in a profession that is scheduled to work during all days and all hours which shall include commute time, the polls are open on Election Day and no excuse in-person absentee/early voting.
- 8. Election Officers tasked with the Election Administration for the current election cycle.
